Prior to this, Dr Jardines served as National Director for Medical Education (1982-1988), Vice Minister for Medical Education (1988-1997), and Vice Minister for Health Research (1997-2000). Dr Jardines is also a Regional Advisor to the Pan American Health Organization for Human Resources and a member of the International Association for Bioethics.

## Araceli Lantigua Cruz, MD, PhD

2nd Degree Specialist in Clinical Genetics. Dr Lantigua is Vice Director for Teaching at the National Medical Genetics Center and Full Professor at the Higher Institute of Medical Sciences of Havana, where she designed the master's degree program for Clinical Genetics. Additionally, Dr Lantigua is President of the Academic Committee for the master's programs in Medical Genetics and Genetic Counseling. She founded two national reference centers for Clinical Genetics and remains Clinical Genetics department head at Juan Manuel Márquez Pediatric Teaching Hospital, Havana. Dr Lantigua is a member of the Scientific Grading Commission for Biomedical Sciences and the Permanent Tribunal on Biomedical Sciences, where she was President from 2001 to 2005. She has spent over 25 years studying the epidemiology and etiology of mental retardation.

## Nancy Sánchez Tarragó, MSc

A specialist in Technical-Scientific Information and Library Technologies, Sánchez is an Assistant Professor at the Communications School, University of Havana.
